

## CoaguChek XS Pro Medical Mobile Unit: Appendix F - Meter Set Up

### Set the Units



Meter is in Main Menu:

1. Touch the SETUP button.
2. Touch the SCREEN button.
3. Touch the UNITS button.
4. Touch the button to select INR.
5. Touch  to save the selection.
6. Touch to return to Previous Screen.

### Set the Language



Meter is in Main Menu:

1. Touch the SETUP button.
2. Touch the SCREEN button.
3. Touch the LANGUAGE button.
4. Touch the button to select ENGLISH (US).
5. Touch  to save the selection.
6. Touch to return to Previous Screen.

### Set the Beep Tone



Meter is in Main Menu:

1. Touch the SETUP button.
2. Touch the OPTIONS button.
3. Touch the BEEP TONE button.
4. Touch the button to select MODERATE, for the beep tone.
5. Touch the button to select ON, for the key beep.
6. Touch  to save the selection.
7. Touch to return to Previous Screen.

*Note: In the diagram the meter is set to give no beep tone.*

### Set the Auto Off



Meter is in Main Menu:

1. Touch the SETUP button.
2. Touch the OPTIONS button.
3. Touch the AUTO OFF button.
4. Touch the arrow buttons to select from OFF to Sixty minutes. *Set the meter for an Auto Off of five [5] minutes. (Meter will turn itself off automatically if it has not been used for five [5] minutes).*
5. Touch  to save the selection.
6. Touch to return to Previous Screen.
